STALLION SERVICE CONTRACT 2021

1. I hereby agree to breed my mare _____, reg. # _____ to the stallion KT SACRED WAR PAINT standing at Sage Veterinary Services in Baggs, WY in the year 2020 and to pay a total service fee of \$1000.00, of which \$500.00 is tended herewith as a booking fee and the balance to be paid, along with any additional charges incurred, prior to picking up of the mare. If payment is made by credit card, a 3.75% processing fee will be added to the transaction.

2. It is agreeable to check my mare for normal breeding condition and to render any treatment or immunization which may become necessary: the expense of this service to be charged to my account.
Immunizations required prior to arrival at Sage Veterinary Services: Western and Eastern Equine Encephalitis, Tetanus, West Nile Virus, Equine Herpes Virus (EHV-1 and EHV-4), Equine Influenza – If immunization status is unknown, the mare will be vaccinated upon arrival.
3. It is further agreed that should the above named stallion die or become unfit for service, or if my mare should die or become unfit to breed, then this contract shall become null and void and the service fee paid, less booking fee, shall be refunded.
4. It is my understanding that you will not be responsible for accident, sickness, or death to my mare or foal, and that you will exercise your best judgment in supervising and caring for them. I will likewise not be responsible for accident or injury to your stallion or mares.
5. LIVE FOAL GUARANTEE:
Should the mare abort or not have a live foal to stand and nurse, this mare will have a return breeding privilege at no further breeding fee charge, for the next year breeding season only, providing that a certification by a licensed veterinarian of the abortion or birth of a foal which does not stand and nurse is received within seven (7) days of the occurrence. If the mare owner fails to deliver this mare for rebreeding the following year, then any and all fees paid shall not be refundable and the return privilege for rebreeding is cancelled. Sage Veterinary Service must be notified within 45 days from insemination of pregnancy status.
6. BOARD: Wet \$ 14 – paddock with shelter, 24 – inside stall Dry \$ 13 – paddock, 24 – inside stall
The mare will not be released until all charges are paid.
